## From the Treasurer

I am pleased to present the Treasurer's Report for the ACSV for the fiscal year ending 31 December 2023. This report outlines the financial performance of the ACSV, including income, expenses, and the current financial position.

#### **Expenses and Income**

The ACSV has retained a surplus of \$2,201 for FY2023, indicating a stable financial position. This surplus reflects the careful management of resources and diligent budgeting practices.

The assets of the ACSV consist of various items, along with a surplus from the previous conference, totalling assets of \$2,900. Additionally, there is an investment/loan of \$10,000 contributed by the ACSV Founder, dedicated to establishing the organisation.

During FY2023, the ACSV received \$80 in donations. The main source of income was from events and services, generating \$477.

The ACSV incurred various expenses during the fiscal year, totalling \$8,276. These expenses include operating expenses, and short-term governance and registration costs. These short-term costs are expected to reduce in future years.

#### **Preparation of Financial Statements**

The financial statements are presented in Australian Dollars and all values are rounded to the nearest dollars, in accordance with ACNC recommendations.

The financial statements are general purpose financial statements and have been prepared in accordance with Australian Accounting Standards and Interpretations, as appropriate. The financial statements have been prepared on an accruals basis, and are based on historical costs that do not take into account changing money values.

The company determines the estimated useful lives and related depreciation charges for its property and other equipment. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation charge will increase where the useful lives are

less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or will be written off or written down.

The ACSV has maintained a positive financial performance for FY2023, with a retained surplus of \$2,201. The organisation remains committed to effective financial management to ensure continued success.
